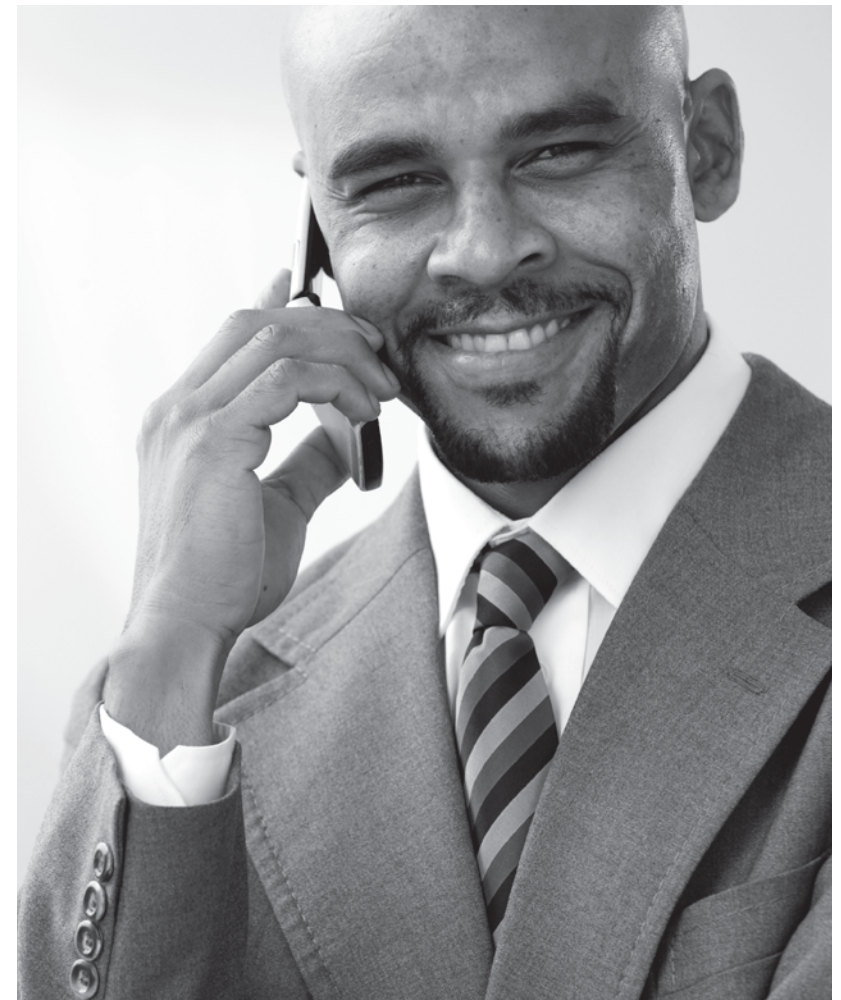

LOSS ADJUSTMENT AND EVALUATION

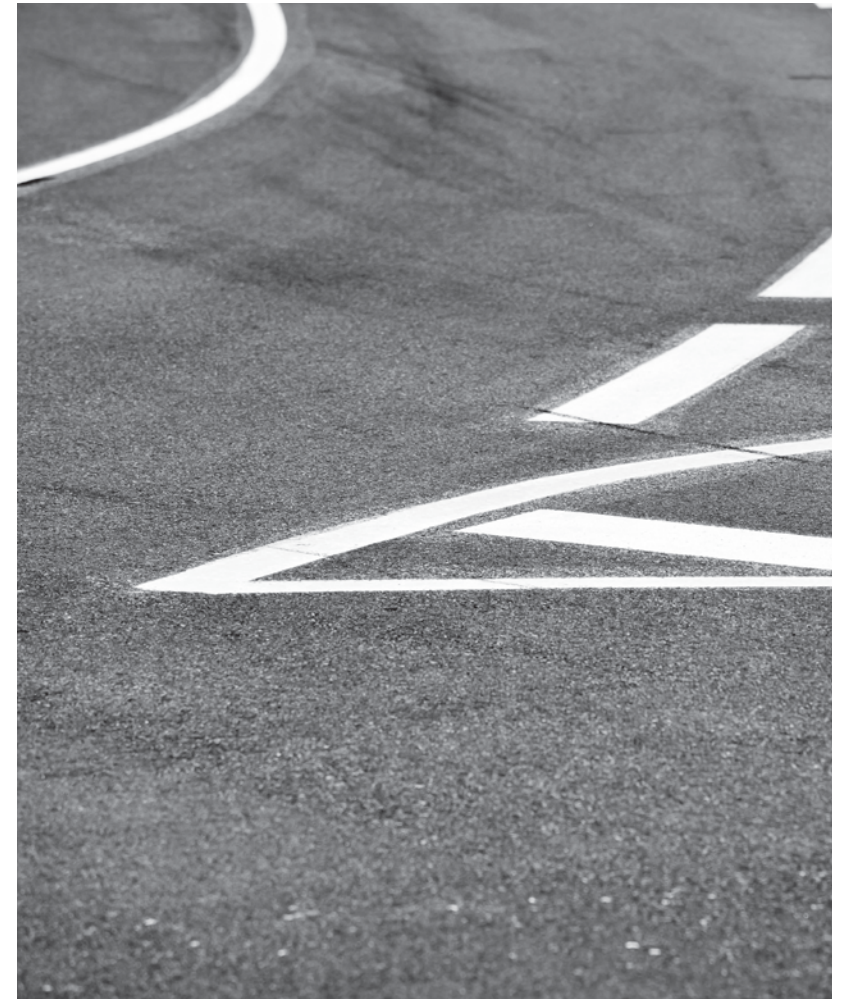

RECONSTRUCTION OF CLAIMS

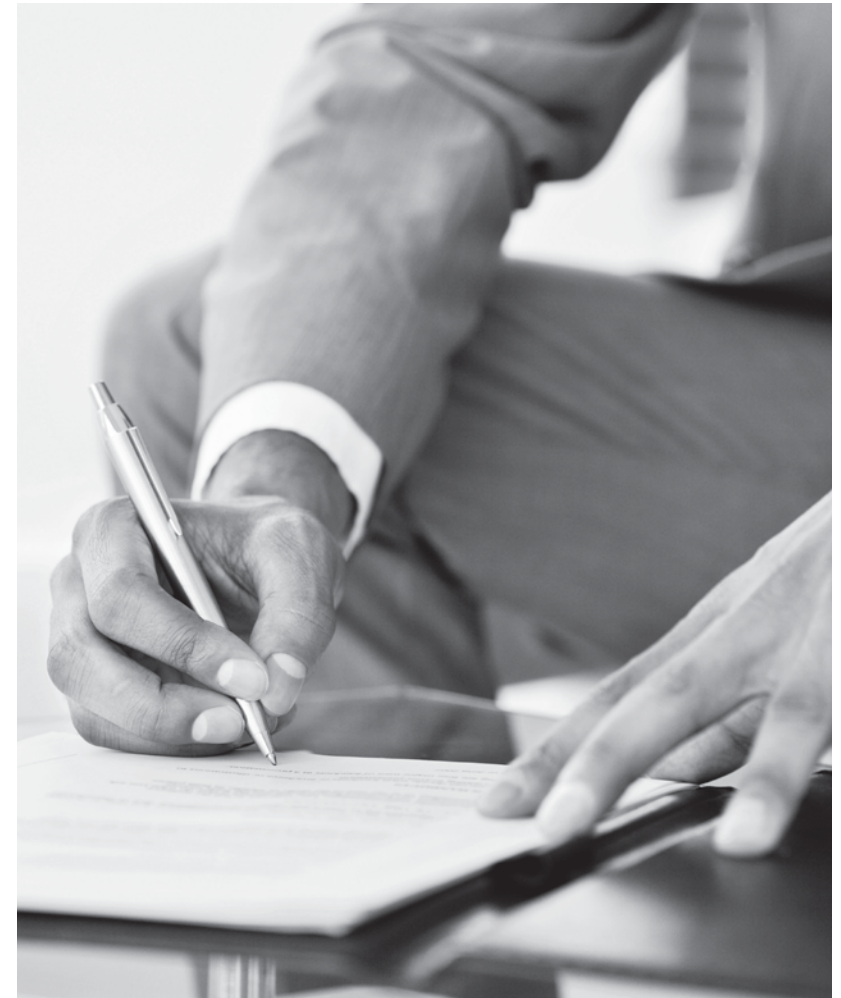

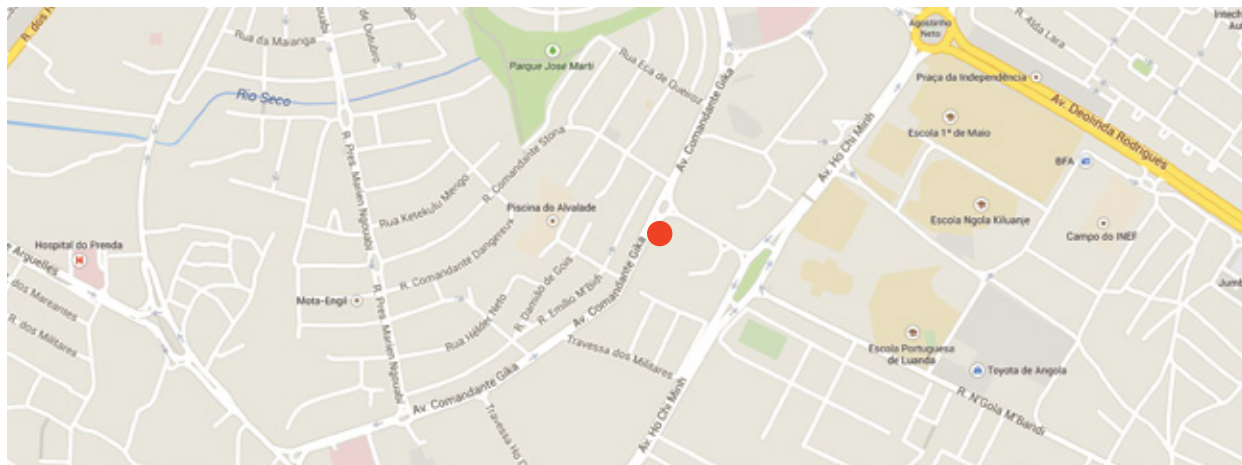




VEHICLE INSPECTION
